ORDINANCE NO. 2022-

AN ORDINANCE AMENDING ORDINANCE NO. 2021-02 AND CORRECTING THE SCRIVENER'S ERRORS TO THE LEGAL DESCRIPTIONS OF THE UPDATED BOUNDARIES OF THE COMMISSIONER DISTRICTS OF PEND OREILLE COUNTY, WASHINGTON AS REQUIRED BY LAW

- WHEREAS, pursuant to the requirements of RCW 29A.76.010 the Board of County Commissioners ("BOCC") have prepared a plan for the redistricting of the county commissioner districts to ensure each commissioner district is approximately equal in population, and
- WHEREAS, pursuant to RCW 29A.76.010 the Board of County Commissioners gave public notice in The Newport Miner of the plan on December 1st and December 8th, 2021, and
- WHEREAS, pursuant to RCW 29A.76.010 the Board of County Commissioners held a public hearing concerning their plan on December 14, 2021 at which time the full Board was present, considered the plan and determined that good cause exists to alter the boundaries of the commissioner districts, and
- WHEREAS, pursuant to RCW 36.32.020 the Board of County Commissioners have divided the county into three commissioner districts, so that each district comprises as nearly as possible of one-third of the population of the county, and
- WHEREAS, the Board of County Commissioners adopted Ordinance No. 2021-02 on December 21, 2021, and
- **WHEREAS,** it was discovered that there were scrivener's errors in the legal descriptions that were adopted in Ordinance No. 2021-02, and
- **WHEREAS**, the Board of County Commissioners gave public notice in The Newport Miner of the plan to correct the scrivener's errors on March 9th and March 16th, 2022 and
- WHEREAS, the Board of County Commissioners held a public hearing concerning their plan on March 22, 2022, at which time the full Board was present and determined that good cause exists to correct the legal descriptions to the commissioner districts.
- NOW, THEREFORE, THE BOARD OF COUNTY COMMISSIONERS DOES ORDAIN that effective January 1, 2022, Pend Oreille County, Washington shall consist of three commissioner districts described on the corrected Schedule A, which is attached hereto and incorporated herein by this reference.

BE IT FURTHER ORDAINED that Ordinance No. 2012-1 is repealed in its entirety upon the effective date of this ordinance.
