The Board considered the 'unique set of conditions' with the property whereas there is riprap on the bank to stop erosion, but is still rapidly eroding. Pictures show no beach, river access is 15 feet straight down, no view, no road, and water is contaminated with hard water deposits. Property allegedly was listed for \$80K without any offers. Motion was made by Margie Fedderly to uphold the Assessor's assessment. Motion was seconded by Bob Sanborn. Motion carried unanimously.
