NOTICE OF MEETING OF THE PEND OREILLE COUNTY BOARD OF EQUALIZATION

NOTICE IS HEREBY GIVEN that the Pend Oreille County Board of Equalization will convene at 10:30 a.m. on July 19, 2017 in the County Commissioners' Hearing Room, 625 West 4th, Newport, Washington, and will continue in session during a 28-day period of not less than three (3) meeting days.

Meetings will be held on July 19, July 26, August 2, August 10, and at other times as necessary to publicly examine and equalize the assessments extended in the current year on the taxable property of said county; to correct all errors in valuation, description or qualities of property assessed by the Assessor; and, to consider a request to reconvene.

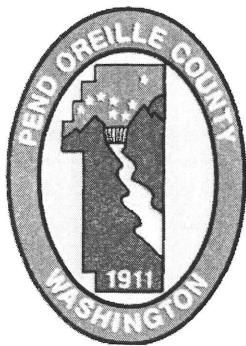
The owner or agent of any taxable property who feels there are inequities in their assessment or exemptions may file a petition and appear before that Board at the time and place appointed. Appeal forms may be acquired from the Clerk of the Board of Equalization, Office of the County Commissioners, 625 West 4th, Newport, Washington. Appeals must be filed by July 1st or within 30 days of the date of postmark on the revaluation notice, whichever date is later.
