

Counter Mitigation Guidelines - June 2023

Traffic infractions: To qualify you must have a timely response, valid driver's license and no FTAs.

Add \$5.00 to reduced amount if two violations in past two years.

Three or more moving violations in past two years = No reduction

If amount is not shown here, multiply and reduce by 15%.

Deferred findings is authorized if no moving violations in the past two years, no deferred in the past 7 years, and with **NO COMMERCIAL DRIVER'S LICENSE**. Pay \$175.00 administrative fee (Additional \$50.00 for each count) due within 60 days.

Non-Traffic infractions: Reduce based upon prior same/similar violations, and must provide proof of correction (example: expired registration would need proof of current registration to be eligible for reduction).

Other infractions:

No Insurance: Dismiss if the driver was insured for the cited vehicle at the time of citation.
Dismissal fee of \$25.00 to be paid immediately.

1st Offense= \$250 with purchase and proof of current insurance

2nd Offense= \$350 with purchase and proof of current insurance

3rd Offense & 3+= NO REDUCTION

No Valid Operator's License 2nd degree: reduce to \$140 w/proof of valid license in a timely manner For Motorcycle Endorsement viol. Proof is needed to reduce. See guidelines for reduction amount.

Negligent Driving 2nd degree: First Negligent driving offense reduce to \$337

No Seatbelt: (Child: dismiss infraction with proof of child seat purchase within 7 days).
2+ violations ever=NO REDUCTION

Handicap parking: Dismiss infraction if driver had placard at time of violation.

Dog Violations: Person appearance in court required to mitigate.

Fail to possess Boater Edu card: Dismiss with proof (if they had it at time of violation) Dismiss with \$50 fee if received after violation.

Parking (Discover Pass/Snow Pass): Dismiss with proof of pass (if they had it at time violation). Dismiss with \$25 fee if purchased after the violation.

INFRACTIONS THAT CANNOT BE REDUCED:

1. **46.16A.030(4)** Failure to initially register vehicle.
2. **46.19.050(10)** Disable parking violations.
3. **46.55.105(2)** Littering abandoned vehicle.
4. **46.61.210** Failure to yield to the right to approaching emergency vehicle.
5. **46.61.212** Failure to yield to stationary emergency vehicle.
6. **46.61.440** Speed in school zone.
7. **46.61.527** Speed in construction zone.

If a defendant is at the counter, writes or calls, and requests to PAY ALL FINES IN FULL (the ones in collections), we may accept the payment, and adjudicate all FTAs. All fines have to be paid in full. The defendant can not request to pay only the traffic infractions. (It's all or nothing.)

*****If the case(s) have been transferred to a civil case then they can not be removed and the defendant needs to contact the collection agency.********

This pertains to emails, calls, letters, etc. if the defendant wants to be set back up on tp.
