Re: Urgent request of Washington State 7th District Legislators and Northeast
Washington County Commissioners

Dear Secretary Nielsen,

We are writing to make you aware of the United States Customs and Border Protection (USCBP) actions to reduce port of entry hours slated for October 1, 2018 that may have negative consequences to both Ferry and Pend Oreille Counties. We believe USCBP's actions, in reducing the port hours for Danville and Metaline Falls run completely counter to President Trump's directives and his task force on rural prosperity. We are asking the USCBP to cease and desist the October 1st 2018 date in order for them to implement the proper procedure in making such a decision.

We are offended and beyond exasperated at the lack of regard USCBP has shown for the economy and quality of life in Ferry and Pend Oreille Counties and the hardship its decision to reduce border crossing hours will have on our citizens and small businesses, an area that consistently suffers double-digit unemployment. This decision may impact a \$1 million USDA loan that was recently awarded to one of our small businesses in Ferry County along with the SBA business plan for another small business in Ferry County. It also has the potential to negatively impact a planned increase in production output of the Pend Oreille Mine in Metaline Falls. Our economy is under industrialized, based on cross border commerce and natural resources. In other words, does the USCBP have a mission to close rural crossings without regard to economic consequences to the taxpayers?

We believe that the reduction of hours will cause a negative cultural shift within our counties. Speaking from past experience, when industry closes there is a rise in criminal activities such as breaking and entering and petty theft. Public safety is another consideration. With reduced hours, any traffic sent on the "alternate route" will have to needlessly travel an additional 30 to 70 miles over mountain passes in the wintertime, putting those travelers in harm's way. How does that help "Make America Great"?

USCBP's impending decision lacks meaningful involvement with our citizens and local elected officials, lacks any desire to understand the unique economy and relationship we

have with our neighbors to the north, and demonstrates an unwillingness to adjust border hours in a way that does not undermine our rural communities' economy. USCBP led its "purported community involvement" with a decision they had already made. Further, USCBP's involvement with our communities consisted of one public meeting in Colville (not in the affected communities of Ferry or Pend Oreille Counties). Its "public outreach" consisted of media releases stating their decision sent to weekly papers only 6 days (including Saturday and Sunday) ahead of the meeting.

As a result, we took the unprecedented step as local state legislators and local elected officials to seek USCBP's data and decision-making process through a formal freedom of information act (FOIA) request. That request was formally submitted to USCBP on July 10, 2018 and they have acknowledged receipt. With less than 13 days to go until the port of entry hours are changed to the detriment of our local economy, we have yet to receive a response to our FOIA.

To no avail, we have asked USCBP to temporarily suspend its decision to so we can all sit down together and look at options that will address USCBP's concerns in a way that will allow our local businesses and our neighbors to the north to thrive and prosper. We do not believe our request is unreasonable. To do so would preserve President Trump's principles and desire to make our country prosperous, regardless of where a person lives or works.

As a key member of President's Trump's cabinet, we ask for your help. Thank you for your immediate consideration, your commitment to the safety of our country here and abroad, the security of our citizens and your service to the United States of America.
